# COOKIES POLICY - v.3 - 21.12.2021 -

This privacy policy summarizes information that may concern the user, their preferences, or Internet access device (computer, tablet or mobile phone) and is mainly used to adjust the website functioning based on users' expectations, thus offering a better browsing experience as well as delivering personalized promotional messages.
